1. Introduction

1.1 Invitation to Bid

Andhra Pradesh State FiberNet Limited (APSFL), a fully owned entity of the Govt. of Andhra Pradesh (AP), having its Registered Office at 3rd Floor, NTR Administrative Block, Pandit Nehru Bus Station, NH – 65, Vijayawada – 520001, Andhra Pradesh, India, invites responses (“Proposals”/“Bids”) to this Request for Proposal (“RFP”) for c.

The selected agency has to support APSFL in promoting and delivering triple play services to households.

Interested bidders are advised to study this RFP carefully before submitting the proposals in response to the RFP. Submission of a proposal in response to this RFP shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.

Interested bidders may download the RFP from www.apsfl.in. Any subsequent corrigenda/clarifications shall also be made available. Proposals must be received not later than time and date mentioned in the key events and dates. Proposals, received after the deadline WILL NOT be considered in this procurement process.

in APSFL office at Vijayawada on or before bid submission due date and this will be the primary requirement to consider the bid responsive.

- b. The bidders shall furnish the original Certificates/documents refer to clause no. 2.2 before bid submission due time, either personally or through courier or post and the receipt of the same within the stipulated date shall be taken.
- c. APSFL will not take any responsibility for any delay in receipt/non-receipt of original BG towards EMD, Certificates/Documents from the bidder before the stipulated time.

2. Instructions to Bidder

2.1 General

1. The Letter of Empanelment, for each of the cluster area, will be issued only to the Bidder(s) who are qualified as per the requirements of this RFP
2. The applicant should submit all the necessary documents/ proofs/ declarations as per the requirement of this RFP in prescribed formats to record their participation and facilitate the evaluation process.
3. Proposals without necessary supporting documents or without meeting the prescribed qualification criteria will be treated as non-responsive and will not be considered for further evaluation.
4. The bid shall be evaluated by a Bid evaluation committee and Bid approval authority
5. The Bid evaluation committee / Bid approval authority / APSFL reserves the right to cancel the RFP, at any stage, without assigning any reason to the applicant(s)
6. Bid evaluation committee / Bid approval authority / APSFL reserves the right to request for any document/ clarification from the applicant(s) which the authority feels that it is required to facilitate the evaluation process
7. In case of any discrepancies or disputes arises, for reasons whatsoever, APSFL reserves the rights to take appropriate action on the tender evaluation and/or the empanelment, restricted only to the respective 'Cluster' area(s). Such cases shall not affect the tender evaluation and/or the empanelment of the remaining cluster areas.

Note : All documents shall be duly signed by the authorized signatory only. The proof of authorization is the Power of Attorney document which is to be submitted as per Annexure I.

2.3 Earnest Money Deposit (EMD)

1. Bidders shall submit an EMD as per the Key events & dates along with their Bids, in the form of Bank Guarantee issued by any Nationalized/ Scheduled Commercial bank in favor of Andhra Pradesh State FiberNet Limited, payable at Vijayawada, and should be valid for 180 days from the due date of the RFP. The format for the Bank Guarantee of EMD is enclosed in Annexure E.
2. The EMD amount is interest free and will be refundable to the unsuccessful bidders without any accrued interest on it.
3. The bid / proposal submitted without EMD, mentioned above, will be summarily rejected.
4. The EMD may be forfeited:
 - a. If the Successful Bidder fails to sign the contract and submit Performance Bank Guarantee within the stipulated period.
 - b. In case the documents submitted, or the information furnished by the bidder are found to be not genuine/false/illegally obtained.

2.4 Bank Guarantee for Performance

1. The Performance Bank Guarantee (PBG) should be from a Nationalized/Scheduled Commercial Bank acceptable to APSFL, in the format prescribed in this RFP as per Annexure F, payable on demand, for the due performance and fulfillment of the Agreement by the Bidder.

2. This Performance Bank Guarantee shall be for an amount equivalent to INR Rs14,55,300/- and shall be submitted by the the successful bidder. All incidental charges whatsoever such as premium, commission etc., with respect to the Performance Guarantee shall be borne by the Bidder. The Performance Bank Guarantee shall be valid for 365 days. Subject to the terms and conditions in the Performance Bank Guarantee, at the end of project the final acceptance sign off, the Performance Bank Guarantee may be discharged/ returned by APSFL upon being satisfied that there has been due performance of obligations of the Bidder under the agreement. However, no interest shall be payable on Performance Bank Guarantee.
3. APSFL reserves the right to forfeit the Performance Bank Guarantee up to 100% of its value on prorata basis at 10% of the PBG value for 10% of non-performance or non-fulfillment of the empanelment commitments i.e., last mile uptime of 99% to subscribers and increasing new subscriptions of 9,900 for the first year and 15% year on year increase thereafter. In such case, the selected bidder shall restore the PBG value to its original value.

3. Background

Andhra Pradesh State FiberNet Limited (APSFL) is a fully owned entity of the Government of AP, under Infrastructure & Investment Department, with an aim to promote digital inclusiveness in rural areas at an affordable cost. APSFL has a ubiquitous network connecting every nook and corner of the state. By September 2023, APSFL shall have over 80,000 Kms of Optical fiber Network and Point of presence in GP in all Gram Panchayats across the state of Andhra Pradesh.

APSFL provides internet and bandwidth services to Domestic households and enterprises across the State. APSFL's flagship product - The Triple Play services (Internet, TV & Telephone) at the price equal to that of the cable TV service has revolutionized the TV and Internet market in AP. The last mile delivery of services in APSFL are provided by the Cable Operators.

In this regard, APSFL intend to onboard Cable Operators for each of the predefined areas, hereafter referred to as 'Clusters' to provide last mile services to households. However, the revenue received from monthly rentals (as per the Package price) shall be shared between APSFL and the Cable operator as per section 7 of this RFP

4. Scope & Responsibilities of the empaneled bidder

1. The successfully empanelled bidder shall be allowed to acquire domestic subscription for the entire Area except the existing domestic subscribers where APSFL services have already been provided.

2. The successfully empanelled bidder shall be responsible for procuring, installing and maintaining the Triple-Play boxes (set top boxes/ CPE boxes) from her/his choice of supplier empanelled by APSFL. The list of the empanelled suppliers of the boxes are available in APSFL website and/or shall be communicated to the empanelled agency from time to time.
3. The successfully empanelled bidder shall be responsible for laying and maintaining the last-mile optical fiber from APSFL's Point of Presence (PoP) location to the subscriber households.
4. The successfully empanelled bidder shall be responsible for maintaining a network uptime of 99% for the last mile network laid by the bidder
5. The successfully empanelled bidder shall be responsible for providing/upgrading services as per the request of subscriber.
6. The successfully empanelled bidder shall be responsible for increasing the subscriber base for respective Cluster areas at a rate of 9,900 new subscribers per each year
7. The successfully empanelled bidder shall be responsible for providing services of APSFL to the subscribers, for a period of 5 years from the date of empanelment, duly adhering to all other responsibilities mentioned in this RFP document.

5. Conditions of Empanelment

1. Bidder shall be requested to bid among the list of the Clusters (Annexure A). Bidder shall be allowed to bid for a maximum of 3 Clusters.
2. Bidding is for the new connections expected to be handled by the selected bidder/Cable operators. However, the existing Cable operators will continue for the existing connections of APSFL.
3. APSFL reserves the right to cancel the empanelment of the bidders in case of nonperformance in providing quality services i.e., last mile uptime of 99% to subscribers and nonperformance in increasing new subscriptions of 9,900 for the first year and 15% year on year increase thereafter.
4. Bidders shall be selected solely based on the selection criteria mentioned in this document
5. In case where any documentary evidence submitted by the bidder is found to be false/forged or incorrect at any time, then the respective bid shall be discarded with no further communication with the bidder

6. In case of any discrepancies or disputes arises, for reasons whatsoever, APSFL reserves the rights to take appropriate action on the tender evaluation and/or the empanelment, only to the respective 'Cluster' area(s). Such cases shall not affect the tender evaluation and/or the empanelment of the remaining cluster areas.

6. Selection Criteria

6.1 Pre-Qualification Criteria

The bidder should satisfy the following Pre-qualification criteria to be eligible for further evaluation under this RFP. The bidder should enclose documentary evidence for fulfilling the Eligibility in the Pre-qualification Bid. If a bidder fails to enclose the documentary proof for eligibility, their bid is liable to be rejected.

3. APSFL shall verify the number of subscriptions being handled by the bidder with the cable TV brand owner or the ISP. In case where the brand owner / ISP denies the authenticity of the document or no response is received from the cable TV brand owner/ISP within 15 days, then the bid will not be considered for further evaluation and with no further communication to the bidder.
4. In case where any documentary evidence submitted by the bidder is found to be false/forged or incorrect at any time, then the respective bid shall be discarded with no further communication with the bidder

Note: APSFL shall verify the number of subscriptions being handled by the bidder with the cable TV brand owner or the ISP. In case where the brand owner / ISP denies the authenticity of the document or no response is received from the cable TV brand owner/ISP within 15 days, then the bid will not be considered for further evaluation and with no further communication to the bidder.

6.3 Award Criteria

1. **Experience and Financial strength based Selection** method shall be adopted for the evaluation of Bids.
2. Under this method, the Experience will be allotted weightage of 50% while the Financial Strength Proposals will be allotted weightages of 50%.
3. Technical qualifications of the bids qualified in the Pre-qualification stage will only be taken for further evaluation and shall be considered for Selection criteria
4. Selection criteria shall be conducted separately for each of the Cluster Areas
5. Bidder with Maximum 'TECHNICAL SCORE' for the respective Cluster Areas shall be awarded. The Technical Score shall be Sum of 'Experience Score' and 'Financial Score'. The Technical score shall be computed as below

6. 'TECHNICAL SCORE' = **Experience Score + Financial Score**
7. In case where two or more bids receive the same 'Technical Score' for a Cluster area, which is the highest, then the empaneled agency shall be selected on the lottery basis among the bidders of the same score

6.4 Special Conditions

1. A Single bidder can apply only for a maximum of three Cluster Areas. In cases where bidder choose to apply for more than one area the following conditions shall apply
 - a) If the Bidder choose to apply for 2 Cluster then the Experience of the bidder shall be considered as it is for both the Cluster whereas only one - half of the Net worth of the bidder submitted as part of Section 6, shall be considered for 'Technical Score' for each of the applied Cluster
 - b) If the Bidder choose to apply for 3 Cluster then the Experience of the bidder shall be considered as it is for both the Cluster whereas only one - half of the Net worth of the bidder submitted as part of Section 6, shall be considered for 'Technical Score' for each of the applied Cluster
2. Revenue share between APSFL and the Bidder shall be as mentioned in this document under section 7- 'Revenue Share Mechanism'. However, revision of revenue share and subscription prices shall be done from time to time at the sole discretion of APSFL.

7. Revenue Sharing Mechanism

1. The successfully empaneled bidder shall be paid at 67% of the respective Package Price per respective domestic subscriber for the initial 9 consecutive months of the acquiring the respective domestic subscriber.
2. The successfully empaneled bidder shall be paid at 35.5% of the respective Package Price per respective domestic subscriber POST the initial 9 months of the acquiring the respective domestic subscriber.
